## MINUTES OF THE 2014 ANNUAL MEETING

The Annual Business meeting of the Ohio Genealogical Society was held 3 May 2014 at the Kalahari Resort and Conference Center in Sandusky, Ohio. President Sunda Peters called the meeting to order at 12:28 p.m. The assembly joined in reciting the Pledge of Allegiance.

President Peters welcomed everyone to the meeting and thanked the Conference Co-chairs, Margaret Cheney and Susan Zacharias and Fellows & Awards Chair Marleen Applegate. Paul Morehouse moved and Diane Gagel seconded a motion to adopt the agenda. Motion carried. Paul Morehouse moved and Diane Gagel seconded a motion to approve the minutes of the 2013 Annual Meeting as corrected. Motion carried. Both the agenda and the 2013 Meeting minutes were provided to attendees in a meeting brochure.

Treasurer Bob Keener gave the Treasurer's report. Total net assets as of 31 December 2013 were \$2,357,582 vs. net assets as of 31 December 2012 of \$2,295,327, an increase of \$62,255.

President Sunda Peters presented the highlights of her report, which was printed in full in the meeting brochure.

Library Director Tom Neel gave a brief summary of the report "OGS 2013 Year in Review", which was printed in full in the meeting brochure. He urged OGS members to become more involved by volunteering, donating money, writing articles for OGS journals, and genealogy programing.

President Peters introduced the trustees and officers of OGS. The officers then introduced the Chairs of Committees under their jurisdiction. The President then introduced the OGS staff.

Marleen Applegate recognized the 5 and 10-year anniversaries of 15 OGS chapters and then followed with presentations of the

Chapter and Book Awards. Chapter Officer of the Year went to Missy Derrenberger of Richland County and Chapter Volunteer of the Year went to Philip Leonard of Richland County.

The OGS Fellow Award was presented to Joan Hamilton Wyatt and Susan Zacharias for their outstanding service to OGS over the years.

Kay Hudson presented the awards for the OGS Writing Contest. Overall winner was Deb Root Shell.

President Sunda Peters presented the OGS President's Award to two extraordinary volunteers:

John Early for his many volunteer hours given to OGS;  
Carla Cegielski for her exceptional work as OGS Webmaster

Eric Johnson, chair of the Nominations and Elections Committee, announced the results of the 2014 officer and trustee elections.

Jean Barnes installed Margaret Cheney as the new President of OGS. Sunda Peters installed the other newly elected and re-elected Officers and Trustees.

Ted Minier was not present to give a Fund Development report. Kenny Burck announced the upcoming 2015 Chapter Management Seminar on 9 August 2014 in Lebanon, Ohio. Margaret Cheney announced that Josh Taylor will be the speaker at the Fall Seminar on 4 October 2014. Library Director Tom Neel announced the 2014 Librarians Seminar in October. Kay Hudson announced that the 2015 OGS Conference will be held at the Sheraton Hotel at Capitol Square in Columbus 9 - 11 April 2015.

## TREASURER'S REPORT

---

### Budget Performance

Total revenue from operations (operating revenue, dividends, building fund donations, and life memberships) for the year of 2014 were \$427,383 vs. expenses (exclusive of depreciation) of \$454,775 for an operating deficit of \$27,392.

### Total Net Assets

Total Net Assets as of 31 December 2014 were \$2,262,997 vs. net assets as of 31 December 2013 of \$2,357,582.

### Investment Status

The OGS Fidelity Account, primarily representing our Endowment Fund, was valued at \$544,725 as of March 20, 2015.

### FDA Loan

The remaining balance on our loan from the Federal Department of Agriculture as of December 31, 2014 is \$257,116.19 vs. a balance on December 31, 2013 of \$433,050.88.

While our financial condition remains stable, it is increasingly obvious that our business model is obsolete and needs to be brought into the 21st century by taking advantage of the huge leaps in technology and communications that have occurred over the past two decades. Our membership has been slowly declining for the past few years as people use the internet for their research. It is imperative that we take advantage of the wonderful resources that are our most significant asset to allow people to access them remotely.

## OGS 2014 YEAR IN REVIEW

---

Any review of the previous year in an organization's history may be outlined as a series of facts, and then one compares the data to the group's mission and goals with a thought to the future to ensure sustained viability. It is always amazing to me how a volunteer organization can accomplish so much in a year, and 2014 is no different for the Ohio Genealogical Society.

- Ohio Civil War applications database extract completed
- Ohio Digital Library added to OGS web site with over 125 titles digitized in first year
- Winton Arnold, past OGS Trustee, the first 100-year old in Century Families of Ohio
- Early Ohioans Residences from the Land Grant Records reprinted
- FamilySearch team at OGS began scanning of over 600,000 Ohio obituary cards
- \$2000 NHPRC grant – The Ohio Story Scripts: Bringing Old Radio Back to Life – 3 interns completed this massive digital collection now at [www.ogsarchive.org](http://www.ogsarchive.org)
- Multiyear “Kickstart” Campaign completed with matching grant by Samuel Isaly to get half the building loan with USDA paid off (\$369,704 raised)
- NDNP Project to add Ohio digital newspapers to Chronicling America ending last grant cycle – OGS Library Director served on the committee representing OGS throughout the project
- Ohio Library Council Subject & Special Collections Division – Library Director elected to a two year term 2015-16 representing OGS
- Southwest Cuyahoga County Chapter disbanded, but a new Shelby County Chapter is ready to come on board in 2015!
- OGS welcomed a new President, Margaret Cheney, of Elyria
- OGS Conference at Kalahari – new resort experience brings many new members to OGS – with the help of our tour guides “George” and “Leonard”
- OGS represented at NGS Conference in Richmond VA and National Pal-Am Conference in Columbus OH
- Large library donations included Robert Longbottom Collection (over 100 volumes on Bedford-Blair Co PA); Draper Manuscripts nicely bound; 130-volume Official Records of the Union & Confederate Armies from Franklin Public Library; original Richland County naturalization records; Wayne County Cemetery Preservation Society volumes (35 books); Russell Earnest Associatesaktur series; and much more!
- 50,000 obituaries entered in Hayes Ohio Obituary Project in first six months – [index.rbhayes.org](http://index.rbhayes.org)

- OGS Fall Conference with Josh Taylor our largest ever!
- GenLib Seminar popular as always as well as our summer schedule of library classes
- Endowment Fund and Building Fund plaques put up recognizing our largest donors
- Ohio's Black Soldiers in the Civil War published (first OGS book available on Kindle)
- Also published Grave Marking Ceremonies: Planning and Conducting an Event
- Fundraising - \$106,990.77 total donations with the break down: \$82,852.49 Building Fund, \$2,070.00 Endowment Fund, \$8,250.00 Life Membership, \$4,625.00 Sustaining Membership, \$9,193.27 Operating Fund
- We began the year with 5497 members (653 of those digital) and ended the year with 5356 members (820 of those digital)
- The library had 4545 patrons in 2014 (compared to 4930 in 2013)
- 3512 new titles were acquired with 4345 titles added to the online catalog; the acquisition log at the end of the year totals 58,347 books with 49,456 of these catalogued
- 4225 volunteer hours were contributed in the library; many additional hours were given by off-site board members, committees, and volunteers
- The OGS web site is most impressive with 156,439 unique users; 435,740 visits; and 2.9 million page views during 2014

These are just a few of the many accomplishments of many people in 2014, but one must look at the big picture. We have been very successful with a 2.3 million dollar library project and the loan is now manageable just five years out, but the measure of success in a society is the completion of its public projects. Donations should be aimed at operational goals. Increased reference services, our digital library, the OGS web site, database (index) preparation, manuscript processing, shelving for our incoming collections, and the acquisition of Ohio books and microfilms and electronic resources are all at the top of the list. They all take money and a dedicated staff which takes even more money. We must treat OGS as the caretaker of Ohio's records dealing with our ancestral families and remember OGS in our will bequests and estate planning just like your local museum or college giving plan are important to you. OGS is a charitable institution and we can only survive through the generosity of donors. At the same time, we

realize that the "society" or social group as we know it is diminishing. We see it in every branch of today's society. We must sell ourselves and convince our friends to pay that \$35 membership fee each year. The online vendors have fantastic resources and they are new and wonderful and expanding, but there is value to exploring the world outside of your home computer. Listening to a good speaker, photographing a tombstone for that contact in another state, sharing stories of courthouse adventures with friends, going with a group on an overnight excursion to a conference or a library facility, extracting records and publishing them for the benefit of others in a community in which you may have no familial connection – these are all the extra benefits of participating in a society like OGS – the "add-ons", if you will, to those online publications, blogs, and Facebook chatter that keep us up at night. Spread the word and promote the organization that you believe in through your voice, if not by your pocket. This is how the Ohio Genealogical Society can grow and mature and maintain its viability in the future!
