MATERIALS FROM LANDAMERICA

1) Full Abstract Files, Odell Files and Office Files: Odell was an early abstracter in the 1800's of land records in the Cuyahoga Co. Ohio area. There is miscellaneous information found in these files, including estates, affidavits, incompetency files, adoption files, and other items, such as maps.

2) Index Cards for Cuyahoga County Ohio Court Files: These contain 1) all federal court items that affect real property from apx. 1898-1971; 2) all probate (except land sales); 3) all divorces from 1904 up to 1954. They are color coded which makes them better than being microfilmed. They contain names and case numbers which can lead a person to other records at the court or possibly in the Odell files.

3) 5 file card cabinets

4) one 7 foot cabinet which will house the Full Abstracts, Odell files, and Office Files

5) "Found Out" Index book--also for Odell items

6) Odell index cards for land, arranged a) by original lot and b) by sub-division

7) A copy of the "Boiler Plate" items used for the beginning of all Full Abstracts

8) Full Abstract Index

9) Cleveland and Suburban City Directories (any duplicates could be sold)

Cuyahoga County Ohio Case File Index

This material was donated to the Ohio Genealogical Society by the late John Grecol, Fairview Park, Ohio in 1999 through OGS Cleveland District trustees Dianne Young and Jean Barnes. The cards were produced by Cuyahoga Abstract Title and Trust Company and its successors, the last being LandAmerica, 1500 W Third Street, Cleveland OH. These served as an access point to court records for the title company and represented documents that named heirs where property could be transferred. The cards gave the case number so that the original papers and eventually the proper microfilm roll could be pulled while doing title abstract work. The cards contain all federal court items that affected real property from approximately 1898 to 1971, all probate case items (except land sales), and all divorces from 1904 to 1954.

In addition to information provided by the donor, John Grecol, the card files were reviewed in October 2014 at the OGS Library by Sherry Minn who used to work for Lawyer's Title in this file and who now is employed by PDG Exams, Inc., an abstract firm. The goal was to come up with explanations for many of the abbreviations used in the cards. Once the case type is determined, the researcher can then use the case number to determine the microfilm roll or original record location at the Cuyahoga County courthouse. Some older materials may be with the Cuyahoga County Archives.

Sherry Minn notes that the cards were microfilmed by the courts at one time, but these films were destroyed when O'Malley was County Recorder. The OGS card file is therefore unique at this point. She also notes that some record types (liens) were only 5 or 6 year holds and therefore were not of any permanent value. When case files were filmed many of these cases were tossed before filming and the original document no longer exists, but the card may still be in the index.

Researchers with Cuyahoga County families are generally able to find cases in this index. Most of the record types are indexed individually at the courthouse but many not beyond the volume level. This overall index, therefore, is extremely valuable to genealogists and historians. Locating the original case at the courthouse is easier if the researcher knows that it existed at one time. With record losses and rearrangement of record groups, some searches may prove fruitless. Mrs. Minn stated that most cases were available in the courthouse at 1 Lakeside Avenue when she worked there. She rarely had to go to the Cuyahoga Archives to retrieve a case. If the reference is to a deed or mortgage, these are now online through the Recorder's Office since 1810. Because Cleveland and Cuyahoga County is such a populated area, there are many duplicate names. Do not assume that all case numbers on a card refer to your family member. They may be different people of the same name.

COLOR – Mrs. Minn said that they paid no attention to card color in the years she worked for the firm, but it is evident that in earlier years, each color went with a record type. For example, divorces always seem to be on orange cards. Mr. Grecol noted the color scheme in his notes. In the FamilySearch digitization process, the color will probably be lost, but the abbreviation noted on most cards is the key to the record type.

NUMBER – The number is the case number. The original cases were filed by number and the order on the microfilm should be by this number. Mrs. Minn noted that a new numbering system began in 1998.

ABBREVIATIONS – OGS spent several hours with the former employee Sherry Minn simply pulling cards at random. When we encountered a new abbreviation, she tried to recall the meaning. Some were so rarely used that she would have had to ask the meaning when she worked there. She couldn't recall others and these are marked with a question mark. Because our study was at random, we may have missed abbreviations in this process. If something is uncertain, check with the courthouse employees and see if they can make suggestions.

#'s – a number only is probably a regular Probate case

#'s (cards with lots of numbers) – these are Common Pleas case; often some numbers are crossed out on these but Mrs. Minn did not know the reason.

Adopt – usually the adopted name; sometimes the original.

Adptr – Adoptor (the person who adopted the child) – some of these may be closed files.

Aff – Affidavit (could be Recorder or Probate – cannot tell by number)

Aff Ct Carbon [number] – (“carbon” was just a title company term that signified that another company had been in and copied a particular case; there will be no record except for the original case)

Agmt – Agreement

Agmt Arb – Agreement to Arbitrate – this is in Probate; they wanted a judge to make the decision in a case.

Ali – Alias

Ante Nuptl Agm Rec – nuptial agreement that might be in Probate court.

Asmt PipeLn RW – Assignment of Pipeline Right of Way – often gives the village/township location and volume and page. A building might use this when putting in a new subdivision.

Asmnt or Asnt Mtg – Assignment of a mortgage (often gives volume and page)

Attested Acct – Attested Account is in Probate; they are having an argument about something in the case.

Aud S – Auditor's Sale

Aud Tax – Auditor's Tax Sale – someone was not paying taxes on the property and it defaulted to the county and was sold by the Auditor.

B – Bankruptcy (see Bkcy)

Birth Ctf Rec – someone filed a birth certificate with the court

Bkcy – Bankruptcy (for example, the card might say "B63-1864 Tol Bkcy". This means that the bankruptcy is from 1963, the number 1864 is the case number, and it comes out of the Toledo courts).

C of A – Court of Appeals

Cert Copy – a note that someone has simply ordered a copy of a case, generally for the Recorder.

Cert of Dev – Certificate of Devise. They are found in the Recorder's Office, usually a half sheet of paper. This was used in cases where the person really had no or little estate, and the court stated that all owned went to a designee. The clerk handled the estate where now it would have to go through Probate.

Ch of Nm – Change of Name (Probate, but early cases were in Clerk of Courts)

Cl Bkcy – Cleveland Bankruptcy

Colored – race (this seems to be noted only in older cases, prior to Civil War)

Compel Distr Judg – Distribution Judgment (the court makes a decision in a judgment)

Comr D – Commissioner's Deed

Conc - ? (with an Also Known As case)

Conf S – Confirmation of Sale – this was used in foreclosures.

Construe – probably contesting a will

Ct Bd – Court Bond

Dec Judgmt or Decl Judgmt – Declaratory Judgment (determination of heirs and court is declaring something)

Decln – Declaration

Des of Hshp – person is declared a Devise of Hardship

Det Heirshp – Determination of Heirship (someone is deceased, and if there is a question, the people come into the court with their records to see if it is enough to prove that they are heirs).

Disln of Ptnshp – Dissolution of Partnership, filed with the Recorder (now are filed just with the state and are online under the Ohio Secretary of State's office).

Dismt – dismissed

Dissln & Recvr – Dissolution and Receivership (in Probate court; something has been dissolved, usually a business).

Div – Divorce (Clerk of Courts, later cases in Probate)

Div FMT - ?

Ease – Easement

Epi – perhaps stands for Epilepsy (seems to be with Insane cases)

Est - Estate

Est F A - ?

Ex – Exemplified

Exem – Exemplified copy of will

Exemplified copy of a will (maybe someone died out of state, and there was property in Cuyahoga County, the court had to get a certified copy of the will and file it in Probate here)

FA - ?

Feeble-Minded – Insane cases (Probate, but generally are closed).

FMY - ?

Gdn – Guardianship

Gdnshp Hab – Guardianship of a Habitual Drunkard

Gdnshp Incompt – Guardianship record of an incompetent person. There may be closure restrictions on some insanity and adoption cases.

Gen Ct Bond – General Court Bond. This was in the Recorder's Office. It was good for 5 years, so the file probably no longer exists. The address listed is what was put up for collateral. Someone might be putting up their house so that a person could get out of jail, for example. These are now filed as mortgages.

Handy 16/2 – Aff. (Many names like this are for Cleveland subdivisions, and the user just has to be familiar with this to understand the reference. This would be a case in the Handy Subdivision on Map #16, page 2, and an affidavit was given.)

Highlights – Not sure what the highlighted cases are, but suspect that these cases have been dismissed. (For example, the husband might have filed a divorce case, the wife might have filed a separate divorce case, and the court might have gone with one or come up with a new number dismissing the others)

Imp – possibly stands for Improved?

Inh Tax – Inheritance Tax (a Probate case; someone inherited something and had to pay the taxes)

[Initials] – Sometimes the title office employees or court officials changed things and would initial and date the card. An example would be if there was a case, but the person died during the process and things changed or the case was dropped.

Ins – Insane

JL – Judgment Lien – These were good for five years so likely were not kept. State Liens were good for ten years. The card may be set up with an a, b, c, etc. The "a" would signify that this is the first lien on the property, etc.

L - ?

LC – Land Contract

Ld S – Land Sale (Probate) – the person probably had no will and the court was asked for permission to sell the property. The first number is often the estate number; the second number is often the land sale number.

Ld S (Admr) – Administrator Land Sale – someone dies and there is no will; the administrator wants to sell the property; these are often in the probate indexes under the administrator rather than the name of the deceased.

LeaseRE – Lease of Real Estate

Ltd Ptnshp – Limited Partnership – might be at Recorder’s office; now with Secretary of State.

Marr Cert – Marriage Certificate

ML – Mechanic’s Lien (someone had work done on their property and did not pay the contractor)

MN – Minor, not of the age of 21.

MU – Municipal Court (the volume and page is often given)

NC – no change

O – in front of a number (when both Probate Court and the Recorder’s Office restarted their numbers, they put an “O” in front of it at first, then forgot about it)

Off Aff – Office Affidavit or Office File - This is a reference note by the title office staff and generally means nothing now. They would often use this if there were a property encroachment.

OL – original lot

P of A – Power of Attorney

PPT – personal property tax

PRem – Premises (would then give the village/township location).

Ptshp Agmt – Partnership Agreement

Ptnshp Rec – Partnership Record (might be at Recorder’s Office, now with Secretary of State)

QCD – Quit Claim Deed (these should be online with the Recorder)

Rec – Record

Rel – release volumes (often assignments are filed here)

Rem – Removal

Rem of Tee Decd – Removal of a Trustee who is Deceased (Probate)

Resub - Resubdivision

Revivor - ?

S B – Sub Book

See Court Slip (is a title company note that now leads nowhere)

SL – Sublot

Slip # - name of subdivision – volume and page of plat – These would be deeds and mortgages that refer to the Cleveland plat map ledgers. It may mean nothing now.

SLS – Sub Lots

Sr. – This means that the person was distinguished as Sr. Sometimes Sr. and Jr. in a family are on the same card.

ST J – State Judgment Lien (often gives volume and page number; good for ten years so original record probably gone before filming).

Sub Contr Lien – Subcontractor Lien – this was good for six years and may not survive; now called a Mechanic's Lien.

Tee Jr – the successor in a trusteeship.

Teeshp – Trusteeship – this was put together to avoid taxes or sometimes was used when a person was declared incompetent.

WD Rec – Warranty Deed Record

ORDER – The title office used a phonetic system in filing, but the cards have since been alphabetized by surname. The title office also combined first names to some extent. For example, Caroline and Carrie and Carolyn would be filed together but there was a see also note to the "K" grouping of those names. It is debatable as to whether the alphabetical or phonetic indexes are easier for the user. Keep an open mind as to spelling variations. There is a key below to help explain the organization of first names.

The following shall constitute the only combinations of Christian names on which court shall be looked when any name in each group is given on the requisition. The See Also names are shown in the right-hand column.
