File 1: Includes photocopies of the Trew family birthday book and family photos. Dates in the birthday book are 1845-1944, and the family dog is included. The birthday book has "To my dear Aunt from her little nephew Bruce, Dec. 25, 1914" written on the front cover page. This is followed by 32 pages of photographs, most dates and subjects unidentified. See also inventory and transcription in front of file by creator, Phebe Trew, 1977.

File 2: Includes photocopies of miscellaneous correspondence, 1981, 7 pages; death certificate for Edward M. Heathman, 1951; copy of 1964 calendar with birthdays, 10 pages; various Trew vital records, 9 pages, dates 1864-1974; and address book, no date, 16 pages.
