Scope and Content: The file contains clippings of the “Snyder County Annals” column which ran in *The Middleburg Post* in Pennsylvania in the 1930s. The clippings document local events that were documented by *The Post* from 1872 to 1894, using the archives at the newspaper. Births, marriages, deaths, and elections are common topics but other unusual events, like accidents, are also often included.

System of Arrangement: Chronological order. For events occurring in December, check the year the event occurred as well as the following year. December was typically included in the following year’s article with January events.
