Custodial History: These court cases were rescued from the demolition of the Richland County Court House in January 1969 by members of the OGS and the Richland County Chapter OGS. They were stored along with hundreds of boxes of other court records in the home of Dr. William R. M. Houston in Mansfield, Ohio.

Scope and Content: The collection contains Criminal Action cases from the Court of Common Pleas in Mansfield, Richland County, Ohio from 1809 to 1948. The bulk of the cases are from 1860-1930s. Most case packets include summons, verdicts, and other original filings. The names of other involved parties, such as the victim of the crime and witnesses, are also given.

System of Arrangement: Boxes are arranged in chronological order by year the case was filed. Within the files, there are two ordering systems. The earliest cases (1809-1896; boxes 63-71) are arranged by the month/year the case was filed with the court as case numbers weren't often assigned. The later cases (1897-1948; boxes 72-135) are in numerical order by case number in the file; there are some overlapping case number ranges between boxes. The index is alphabetized by the surname of the accused.

Access: No access restrictions.

Language: English

Provenance: Donated by Dr. William R. M. Houston's family of Lucas, Ohio; Tucson, Arizona; and Kensington, Maryland, 2012. Additional provenance information about the court records can be found in the finding aid for MSS 330 William R. M. Houston Collection.
