Biography of Creator: *From obituary in the Akron Beacon Journal:*

"He was born August 29, 1922 in Cleveland and lived nearly all his years in the Akron area. He graduated with honors in Mechanical Engineering from the University of Akron, where he also served as president of Lambda Chi Alpha fraternity. Albert had a passion for aviation since childhood, and he became a manager at BF Goodrich's Aerospace Division. He enjoyed flying as a hobby and became certified as an instrument rated instructor. His last flight was on his 85th birthday. Albert also had a strong interest in computers and genealogy, and he produced an authoritative work on the Morlan family of Columbiana County."

File 7: Embree family. Descendants of Moses Embree m. 1803 and Abigail Morlan 1776-? Dates in file 1776-2001.

File 8: Fraizer family. Descendants of Alexander Fraizer d. 1756 and Sarah Coppock (?) no dates. File includes a huge family tree foldout. Dates in file 1674-1989.

File 9: Geiger family. Descendants of Martin Geiger 1794-1862 and Malinda Tilford 1802-1875. Dates in file 1794-2003.

File 10: Hole family. Descendants of Thomas Hole 1589-1679 and Aelanore Douglas no dates. Shows descent from Saxon Kings of England. Dates in file AD 775-2002.

File 11: Hooper family. Descendants of John Henry Hooper 1831-1906 and Pleasant Calkins 1829-1911. Other surname Tipton. Dates in file 1829-1991.

File 12: John family. Descendants of Griffith John 1683-1778 and Ann Williams 1700-1782. Dates in file 1683-1990.

File 13: Kirk family. Descendants of Alphonsus Kirk m. 1692 and Abigail Sharpley d. 1748. Dates in file 1556-1994.

File 13a: LaRue family. Descendants of James LaRue 1744-? And Phebe ? 1742-? Dates in file 1742-1987.

File 14: Mankin family. Descendants of Stephen Mankin 1679-? And Mary Barker 1661-1714. Dates in file 1661-1994.

File 15: Morlan family, part 1. Alternate spelling "Moreland." Descendants of Benjamin Moreland 1630- and wife unknown; Morlan files are arranged by birth date of each individual, with attached genealogical data where available. Dates in file 1620-1799.

File 16: Morlan family, part 2. Dates in file 1800-1899.

File 17: Morlan family, part 3. Dates in file 1900-2002.

File 18: Pierpoint family. Descendants of Francis Pierpoint and Sarah Richardson, no dates for either but oldest child born in 1738. Dates in file 1640-1973.

File 19: Richardson family. Descendants of William Richardson 1633-1697 and Elizabeth Ewan Talbot 1635-1704. She is frequently referred to as "Ewan," since she married Talbot after Richardson died. Dates in file 1633-1996.

File 20: Shaw family. Descendants of Hamilton Shaw d. 1810 and Jane ? 1775-1845. Dates in file 1775-1988.

File 21: Swaim family. Descendants of Robert Swaim no dates and Charlotte Stack d. 1887. Dates in file 1853-1995.

File 22: Talbot family. Descendants of Richard Talbot 1625-1663 and Elizabeth Ewen 1634-1703. Dates in file 1610-1996.

File 23: Tullis family. Descendants of Richard Tullis 1730-1817 and Jane Gibson 1734-1813. File includes a 130 page genealogy. Dates in file 1667-1998.

File 24: Wright family. Descendants of John Wright 1722-? and Judith Easley no dates. File is a 126 page highly detailed genealogy with supporting documents – deeds, wills, etc. Dates in file 1722-1995.
